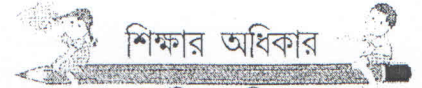



Sub:Final intimation regarding enrolment of Out of School Children.

You are well informed that as per provision of 'RTE Act 2009'-'all children (6-14 years) must be enrolled at their nearest schools. It is unfortunate that only 2145 children of our district (out of 12780) have been enrolled in Primary & Upper School till date. After sending repeated reminder from December till now, a poor response has come from your end. It is not permissible for any ground.100% enrolment of Out of School Children must be achieved within one month. It is a gross violation of RTE Act and against the spirit of the act. Take immediate action in this regard and follow below mentioned procedure, otherwise authority may take disciplinary action against you & your subordinates. This order shall be treated as urgent.

How to enroll them :

- 1) Para teacher of concerned school and Siksha Bandhu will visit house of each & every out of School child and meet their parents and will arrange to enroll them in school within 30/06/2014 positively.
- 2) The Sub-Inspector of School will monitor work of Para Teacher and Siksha Bandhu and also will arrange Special Training for the out of School Children as per requirement.
- 3) On 01.07.2014 the Sub- Inspector of School will submit compliance report that all out of School children have been enrolled in schools.
- 4) The Headmaster/Headmistress of School shall issue working certificate of Para Teacher of his /her school stating clearly how many children are out of school and how many of them have been admitted in school by the Para Teacher concern.
- 5) The Sub -Inspector of School will issue working certificate of Siksha Bandhus.
- 6)The DI of Schools also will monitor work of Sub-Inspector of Schools.
- 7) District SSM Section will monitor progress of enrollment of children daily ^{on} Basis.
