Sub: Opening of savings bank account in a Schedule Bank with Core Banking Services facilities for every eligible students of class (IX-XII) with disabilities covered under the IEDSS Scheme.

Sir/Madam,

You are well aware, the centrally sponsored scheme Inclusive Education for Disabled at Secondary Stage (IEDSS) is being implemented in our district like with the aim of continuing support services to students with disabilities after completion of the elementary level as they pursue their secondary and higher secondary education (from Class IX-XII). The stipulated amount for each eligible student according to the applicable categories and the purposes are given in the scheme. It is felt that in the interest of speedy disbursement of the funds meant to support these children. It is necessary that a savings bank account in a scheduled bank with Core Banking facilities as convenient for the student be opened for each child. The account is to be operated jointly in case the student is minor and independently/singly in case the student has become an adult. These accounts can be jointly operated even in case of a major student but with a non-negotiable condition that the account shall never be operated singly by the other operator. This will also help the students acquire banking and other functional skills. Each such Bank account is to be opened with zero balance. Last date for submission of Bank Accounts details for IEDSS Project in District Project Office, Sarva Siksha Mission, North 24 Parganas is 30/06/2014. Send bank details of CWSNs as per format attached with the letter. Please do not send names of the CWSN who has already received this benefit in previous year.

In this circumstances you are requested to engage Group-C and Special Educator of your CLRC to take immediate steps for opening Bank account of students.
