**NOTIFICATION**

(1) In exercise of the power conferred by section 10, read with section 11, of the West Bengal Scheduled Castes and Scheduled Tribes (Reservation of Vacancies in Services and Posts) Act, 1976 (West Bengal Act XXVII of 1976), and in supersession of all previous orders on the subject, the Governor was pleased to notify the following Model 100-Point Roster with a view to giving effect to the reservation of vacancies for the Scheduled Castes, and the Scheduled Tribes under the said Act, for direct recruitment to vacancies in services and posts in an establishment as defined in the said Act:-

(2) The Governor is further pleased to direct that in the model roster in paragraph (1) shown as 'Unreserved' the 9<sup>th</sup>, 19<sup>th</sup>, 29<sup>th</sup>, 49<sup>th</sup>, 59<sup>th</sup>, 69<sup>th</sup> and 89<sup>th</sup> vacancies shall be reserved for backward classes under Category-B and 6<sup>th</sup>, 13<sup>th</sup>, 26<sup>th</sup>, 38<sup>th</sup>, 45<sup>th</sup>, 52<sup>nd</sup>, 63<sup>rd</sup>, 76<sup>th</sup>, 84<sup>th</sup> and 99<sup>th</sup> vacancies shall be reserved for backward classes under Category-A of backward classes of citizens included in the lists as defined in clause (c) of section 2 of the West Bengal Commission for Backward Classes Act, 1993 (West Bengal Act I of 1993).

(3) This order shall come into force at once.
