## NOTICE

This is to inform all concerned that as per the Guidelines contained in the Courses of Study for Two Year D. EL. ED. Programme, **School Internship for 45 (forty five) days** is obligatory for all students-teachers. It may be noted that School Internship **does not mean teaching practice or Practice-in-Teaching only, but a lot more**. A list of activities during Internship and some guidelines for effective management and control of School Internship are enclosed herewith.

All the heads of Elementary Teacher Education Institutions, offering Two Year D El Ed. Course (through face to face mode), are requested to send the student-teachers to the selected **Primary and Upper Primary Institutions** for such Internship **from 15<sup>th</sup> February to 9<sup>th</sup> April, 2016 (without break) or for 45 effective learning teaching days, whichever is later**, in accordance with the institutional plan of activities. For selection of Institutions they are requested to sit with the Chairman, DPSCs, the D.I./S (PE) and the D.I./s(SE) of the concerned district, and thereafter, to notify the selected schools for the student-teachers, so that each student-teacher can know which schools (Primary & Upper Primary) have been allotted to him/her.

Teacher-Educators of such Institutions should be assigned the responsibility of overseeing the process of the Internship and assessing internally the Interns in terms of the activities, performed.

**GUIDELINES for the Teacher Educators and Second Year Students of Two Year  
D.El.Ed. Course (Revised Syllabus-2014) regarding School Internship for  
45(forty five) days**

1. Internship requires a student-teacher to
  - analyse and evaluate school textbooks and other resource material critically in the context of children's development and pedagogic approach used
  - develop a repertoire of resources which can be used by the internee later in his/her teaching - textbooks, children's literature, activities and games, excursions
  - identify and write down the learning objectives of an input-material/content
  - plan lesson activities and execute the planned lessons/ activities in elementary schools
  - learn practically to relate to and communicate with children
  - reflect critically on practice by visiting a learning centre
  - experience the school in its totality in the midst of activities
  - assume the role of a regular teacher with appropriate planning taking into account the diverse needs of students and the varying contexts that impact the teaching learning process
  - Innovate within existing systemic limitations.
  - learn to conduct meaningful classroom activities by careful selection and organization of such activities
  - observe children and the teaching learning process in a systematic manner
  - critically reflect on his/her own school experiences and keep records of the same
  - learn to assess different aspects of children's learning without focus only on achievement
  - perform effectively in an inclusive classroom
2. For performance of the above-noted activities a student needs to be oriented first and then sent to the school for 45(forty five) days to **perform and deliver in terms of the said activities under the supervision and control of the teacher-educators of the institutions** to which they (student-teachers) belong.
3. In West Bengal classes I—VIII are not held in single schools under single managing authorities.
4. However, the student-teachers should be oriented on and exposed to the whole of the elementary education system functional in both the Primary and Upper-Primary schools. They are required to practise teaching, evaluate performances, plan activities accordingly, for both the primary and secondary school-learners.
5. **The interns are required to plan and deliver lessons on four areas: Language-I, Language-II, Mathematics and EVS.**

6. A student-teacher is required to deliver **at least 10 lessons on each of the four areas**. Of these ten lessons on each area, at least **five should be planned for and delivered in upper primary classes (VI—VIII)**, while the remaining in the Primary Schools.

7. A student teacher must, therefore, be interned in two types of Schools—Primary and Upper Primary, practising teaching in at least two separate classes, one in the range of classes I to IV/V, while the other in the range of V/VI to VIII.

8. Each student teacher must know what has been done before in each subject/area and take up his/her assignment in continuation to make his/her delivery interesting, effective and fruitful.

9. The student-teachers, not delivering lessons, are required to keep themselves engaged in other activities, earmarked for them by the teacher-educators. These activities include, among others, critical observations of peer-lessons. An observation schedule is prescribed below for use during such observations:
